

**Terms and Conditions for the Skinner's Field & Trial x Annie
Tempest Competition
Prize Draw 2026 in association with Annie Tempest.
29.07.2026 – 12.08.2026.**

Eligibility

1. The Skinner's Field & Trial x Annie Tempest Prize Draw ("the Prize Draw") is open to all residents of the United Kingdom aged 18 or over only (proof of ID may be required) and excludes employees and their families of Roger Skinner Ltd ("Skinner's" "we" "us"), its agents, affiliated companies, or anyone else professionally connected with the Prize Draw.

The Prize Draw

2. The Prize Draw opens at 11:00 hours on 29 July 2026 and closes at 18:00 hours on 12 August 2026.
3. There is a total of 1 prize to be won, announced on the 14 August 2026 (a "Prize Draw Day"). 1 prize will be given away on each Prize Draw Day (each an "Prize"). The Prize is limited to one piece of original artwork by Annie Tempest.

Entry Instructions

6. Entry is via Skinner's Field & Trial Instagram and Facebook pages. To be in with a chance of winning a prize, entrants must like and comment on the competition announcement post and submit a photo of their dog to Skinner's via Instagram or Facebook direct message.
7. Only one entry per person via social media. Third party entries and entrants found to be using multiple email accounts to enter the Prize Draw will be ineligible.
